APPOINTMENTS WITHIN THE AEROPORTS DE PARIS GROUP

Augustin de Romanet, Chairman and Chief Executive Officer of Aéroports de Paris, has made the following appointments within the Group:

Alain ZABULON is appointed Director of Security, Risk Management & Compliance at Aéroports de Paris

A former student of the Ecole Nationale d'Administration and holding a Masters degree in economic and social administration, Alain Zabulon has occupied the position of national intelligence coordinator since June 2013. Between 2012 and 2013, he was deputy director of the office of the President of the French Republic. Prior to that, Alain Zabulon was prefect of Landes (2011-2012), prefect of Corrèze (2008-2011), deputy-prefect for equal opportunities to the prefect of Essonne (2006-2008), sub-prefect of Anthony (2003-2006). He reports to Didier Hamon, Group Secretary General.

Aged 59, Alain Zabulon will be replacing Claude Kupfer who previously occupied this position. Augustin de Romanet wished to commend the work undertaken by Claude Kupfer for more than five years as well as his commitment to the Group

Gilles LEVEQUE is appointed Information Systems Director at Aéroports de Paris

A graduate of the Institut National des Sciences Appliquées of Lyon, Gilles Lévêque has been Information Systems Director of the GEODIS Group (French Transport and Logistics company) since 2006. Gilles Lévêque was also Chairman of Géodis Solutions. Prior to that, he held the same position at Hewlett-Packard from 2002 to 2006. Between 1988 and 1992 he was consultant and programme director within Arthur Andersen Consulting.

Aged 55, Gilles Lévêque took up his duties on 1st June as replacement for Philippe Martinet. He reports to Patrick Jeantet, Chief Operating Officer.
