DHL strengthens its presence at Paris-Charles de Gaulle Airport with a new Cargo facility developed by Goodman

DHL Global Forwarding, the air and ocean freight specialist of Deutsche Post DHL, has significantly strengthened its activity at Paris-Charles de Gaulle Airport. Aéroports de Paris, land developer, and Goodman, the project developer and investor, have signed a long-term pre-let agreement whereby Goodman will develop and invest in a 16,000 sqm warehouse and office building for DHL's air cargo activity.



Jean-Claude Levi, President of DHL Global Forwarding France said:

"In order to manage the significant growth of our airfreight volumes, we indeed decided to relocate on Paris CDG airport. Our new secured infrastructures will enable us to optimize our operational performance, thus even better meet our customers' demands. We also will take this opportunity to make specific investments dedicated to different industry sectors such as Luxury and Life Science.

Our main objective is our customers' satisfaction; however, we do not forget our staff whose working conditions will be improved in terms of safety and ergonomics."

Goodman will deliver the property in two phases, with the 12,000 sqm warehouse to be handed over by the end of August 2014, while the 4,000 sqm of office space will be delivered by the end of 2014. The new 16,000 sqm airport logistics facility will enable DHL Global Forwarding to relocate all of its air transit activities to, providing them with direct access to the runways.

Philippe Arfi, Goodman Director France, said:

"Goodman has worked closely with Aéroports de Paris and DHL Global Forwarding to sign a long-term lease for this built-to-suit facility. Our ability to meet all of our customers' requirements, including the specific demands necessitated by airport logistics, was definitively a key advantage for Goodman when working with the parties in this tripartite project. We are proud to support DHL Global Forwarding in the implementation and expansion of their business activities with Paris-Charles de Gaulle Airport."

"After DB-Schenker, Kuehne+Nagel and Bolloré Logistics, DHL Global Forwarding'is getting established at Paris-Charles de Gaulle Airport, demonstrating once again the attractiveness and operational efficiency of our airport. This new step in welcoming world leaders in freight to the Cargo area also strengthens the competitiveness of the airport and shows a strong desire on the part of Aéroports de Paris to support rapid changes and to meet its customers' needs."

With Paris-Charles de Gaulle Airport and Paris-Orly Airport, Aéroports de Paris is the European leader and seventh in the world in air freight transport (including mail). Close to 2.3 million tonnes of air freight goods and mail were processed in 2012, including 2.2 million at Paris-Charles de Gaulle Airport.
