Appointments within Aéroports de Paris Group

Augustin de Romanet, Chairman and Chief Executive Officer of Aéroports de Paris, has made the following appointments within Aéroports de Paris Group:

Franck Goldnadel has been appointed Executive Director, Chief Airport Operations Officer.

He will carry out these duties alongside those of Managing Director of Paris-Charles de Gaulle Airport, a post he has held since 2011. He is also a member of the executive committee and the Group's governing bodies.

Franck Goldnadel, 45, holds an engineering degree from ENAC (the French National School of Civil Aviation). He joined Aéroports de Paris Group in 1993 as General Manager of business development at Alyzia Airport Services, an Aéroports de Paris subsidiary in charge of ground handling services. From 1997 to 2003, he was head of operations at Terminals 1 and 3 at Paris-Charles de Gaulle Airport, and was subsequently appointed General Manager of Terminals 2E, 2F, 2G and the Paris-Charles de Gaulle TGV train station, a position he held from 2003 to 2009.

Between 2010 and 2011, he was Managing Director of Paris-Orly Airport.

Since March 2011, Franck Goldnadel has been Managing Director of Paris-Charles de Gaulle Airport and a member of the Aéroports de Paris executive committee.

Laure Baume has been appointed Executive Director, Director of Aéroports de Paris Customer Division.

Laure Baume, 39, is a graduate of the HEC Business School in Paris. Before joining Aéroports de Paris Group she was Chief Executive Officer New Markets, a member of the Management Committee and Vice President Worldwide Strategic Marketing for the Club Méditerranée Group.

During her time working for Club Méditerranée, Laure Baume also served as Marketing Director, France, Belgium and Switzerland, and Director of Club Méditerranée Switzerland.

Previously, Laure Baume had held several positions of responsibility with Mondelēz International (formerly Kraft Foods) both in France and the USA.

Laure Baume now joins the Aéroports de Paris executive committee.



Alexandra Locquet has been appointed General Manager for the CDG Express project.

Alexandra Locquet, 35, graduated from the IEP (Institute of Political Studies) in Paris. Holding a DESS (Diploma of Higher Specialist Studies) in public administration, she is also a former student of ENA (the Ecole Nationale d'Administration) and was a member of the class of 2006-2008, known as the "*Promotion Simone Weil*".

In 2011, Alexandra Locquet joined the French Ministry of Ecology, Sustainable Development, Transport and Housing, working in the Minister's office as technical advisor responsible for transport. In 2012, she was appointed Assistant General Office Manager reporting to both the Chairman and the Chief Operating Officer of RFF, the owner and manager of the French national railway infrastructure network, a post she held until 2014.

Between 2009 and 2011, she was *chargé de mission* reporting to the Inspector General for Internal Audit and Corporate Planning for the Paris public transport operator, RATP.

Between 2006 and 2009, Alexandra Locquet was assistant head of bureau "research, energy, innovation" and, subsequently, assistant head of bureau "transport" at the Budget Directorate within the French Ministry of the Budget, Public Accounts and State Reform.

She was appointed to the Aéroports de Paris Finance and Strategy Division in April 2014, joining the CDG Express project team to enhance coordination.

Alexandra Locquet will be reporting directly to Edward Arkwright, Aéroports de Paris Executive Director, Finance, Strategy and Administration.

Laure Kermen-Lecuir has been appointed Delegate General of the Aéroports de Paris Foundation. Laure Kermen-Lecuir, 45, joins Aéroports de Paris from her previous post as advisor on local government relations at the French Ministry of Women's Rights.

She holds a postgraduate degree in private law from the University of Paris V-René Descartes, and is a graduate of the CSEN (Centre for Advanced Notarial Studies), in Paris. Laure Kermen-Lecuir began her career in a notary office, before being appointed in 1999 as parliamentary attaché to the Minister of State for Health, Social Action, the Elderly, and the Disabled, under the French Ministry of Employment and Solidarity. From 2004 to 2007, she worked as technical advisor on social affairs for the Oise Departmental Council.

In 2007, she was appointed special advisor on local government relations and decentralised State services in the office of Martin Hirsch, the High Commissioner for Active Solidarity against Poverty and High Commissioner for Youth, where she served until 2010. Subsequently, she worked in a similar capacity at the Civic Service Agency, from 2010 to 2012.
